## PWP ITEM NO. 6804TH RETROFITTING OF NOISE BARRIERS ON TAI PO ROAD (SHA TIN SECTION)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at-grade carriageways, elevated carriageways, footpaths, cycle tracks, amenity areas and central medians within the limit of works area as shown on Plans Nos. ST2078, ST2079 and ST2080 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 5458 published on 30 September 2016 and 7 October 2016. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 5 November 2021 to 4 November 2022, all public or private rights in, upon, under or over the sections of the existing at-grade carriageways, elevated carriageways, footpaths, cycle tracks, amenity areas and central medians to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve installation of semi-enclosures and vertical noise barriers along Tai Po Road (Sha Tin Section) between Scenery Court and Citylink Plaza, installation of cantilevered noise barriers and vertical noise barriers along Shing Mun Tunnel Road near Scenery Court, installation of semi-enclosures along Tai Po Road (Sha Tin Section) near Wo Che Estate, installation of cantilevered noise barriers and vertical noise barriers along the slip road from Tai Po Road (Sha Tin Section) to Fo Tan Road, installation of vertical noise barriers along the slip road from Fo Tan Road to Tai Po Road (Sha Tin Section) and a section of Fo Tan Road, and other ancillary works.

This notice will be affixed on or near the affected at-grade carriageways, elevated carriageways, footpaths, cycle tracks, amenity areas and central medians on 22 October 2021.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
